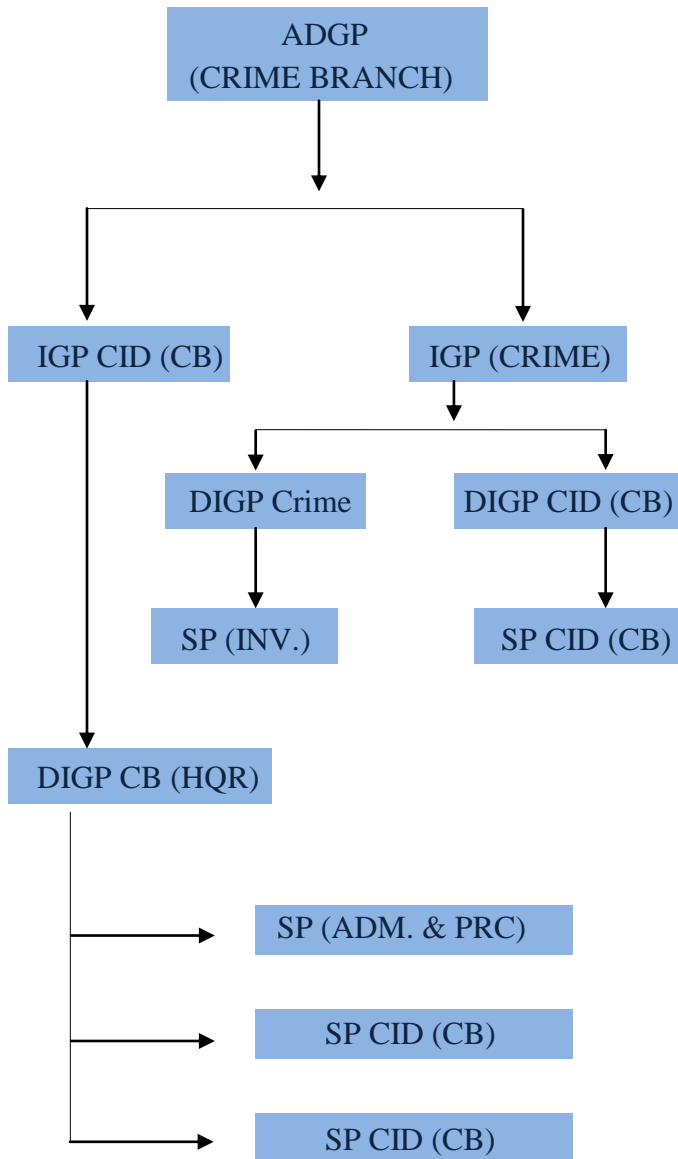


INTRODUCTION: ADGP (CRIME BRANCH) RAJASTHAN



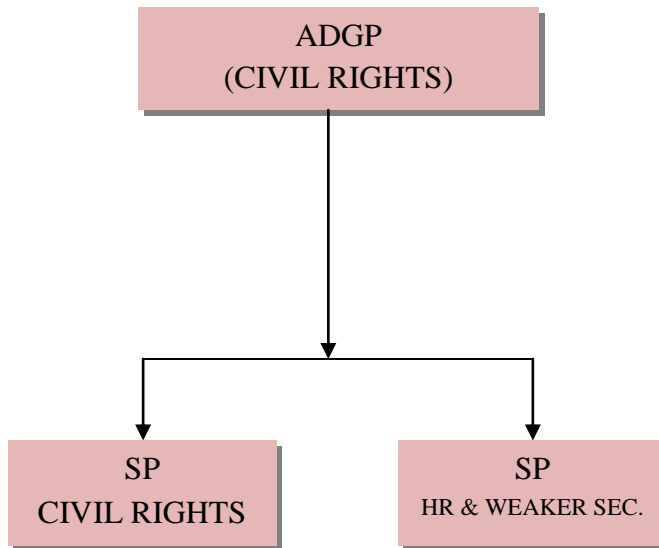
Allocation of Work:

- Matters relating to coordination with CBI, NCB, Interpol and other concerned agencies.
- Matters connected with human rights.
- Policy matters relating to crimes against women, SC, ST and issues related to civil rights.
- Complaints related to investigation.
- Matters related with the Parliament and the State Assembly.
- Rewards relating to crime work.
- Police photography section.
- Police dog squads.
- Public relations.
- Police research and crime statistics.
- Supervising and monitoring of tracing of missing persons and working of missing persons

ADGP (HUMAN RIGHTS AND PROTECTION OF CIVIL RIGHTS)

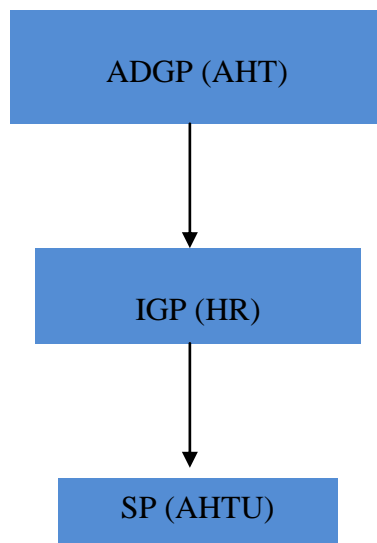


Allocation of Work:

- Crimes against Women.
- All matters pertaining to SC/ST Prevention of atrocities Act and protection of Civil Rights Act.
- He shall be the Nodal officer for communication and co-ordination with SC & ST Commissions and other such commissions.
- He shall be assisted by SP CID CB nominated by ADG CB.

ADGP (ANTI HUMAN TRAFFICKING)



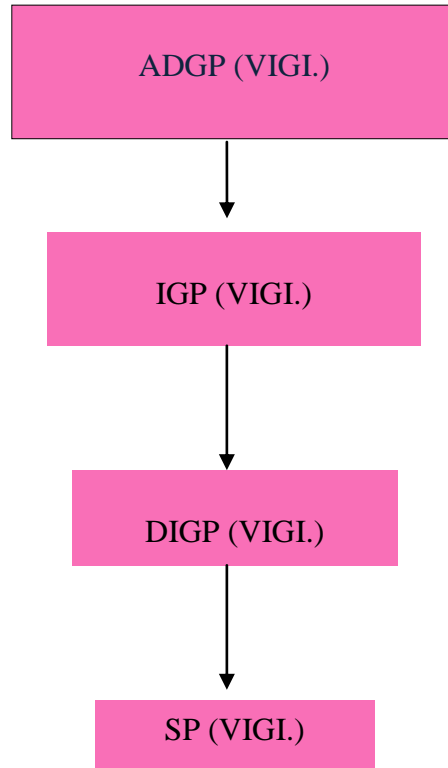
Allocation of Work:

ADG (Anti Human Trafficking) will assist ADG CB in discharge of following functions

- Supervising and monitoring of tracing of missing persons and working of missing persons.
- Cells in different units (districts etc.)
- Matters and references related to NHRC and SHRC, custodial deaths etc
- Matters related to anti human trafficking and monitoring work of district Anti-Human Trafficking cells.

He shall be the Nodal officer for communication and co-ordination with NHRC AND SHRC.

ADGP (VIGILANCE)



Allocation of Work:

- Complaints against police specially relating to
 - Non registration of cases.
 - Use of third degree methods.
 - Corruption in Police.
 - Misconduct which will include drinking on duty and misbehavior
 - Departmental enquiries, suspensions and reinstatement of personnel.
 - Supervision of work Addl. SP (D.E.) and D.E. Section of the PHQ.
- He shall be assisted by **IGP Vigilance** and **S.P. Vigilance** posted in Vigilance Branch.
